The Department of Geography at Trinity College, the University of Dublin, is seeking a motivated researcher to work for a period of 12 months with Professor Anna Davies on the European Research Council (ERC) funded project *SHARECITY: Assessing the practice and sustainability potential of city-based food sharing economies* and additional projects. Professor Anna Davies is the Principal Investigator (PI) and Chair of Geography, Environment and Society at Trinity. This role represents a fantastic opportunity for an enthusiastic candidate to produce meaningful research engagement outputs for the benefit of SMEs, charities and community initiatives in the food sector. The successful applicant will work with the PI to manage, maintain and support use of the SHARE-IT assessment tool for food sharing initiatives:

The researcher will also contribute to the development and delivery of the final (virtual) conference for the project. ## **Standard Duties and Responsibilities of the Post**

The successful candidate will be based in Dublin, Ireland, and will manage maintenance of, and engagement with, the SHARE-IT: <https://shareit.sharecity.ie/> assessment tool, publishing findings in top-quality scholarly journals and other outlets with the PI and other team members as appropriate. They will need to be comfortable managing the day-to-day back-office element of the website tool (guidelines and introduction will be provided) as well as managing and supporting users of the tool. The successful candidate will also be expected to actively contribute to activities including: Writing blog posts and contributing to social and mass media outputs and other communications activities as appropriate; helping with the final conference; assisting with necessary reporting; Attending project meetings.

### **Qualifications**

Applicants **must** hold an MSc (Research Associate) or a PhD (Research Fellow) in a relevant area such as geography, planning, policy studies, politics, sociology, anthropology, urban studies, food or environmental studies.

### **Knowledge & Experience**

The successful candidate will have the following knowledge and experience:

#### **Essential**

- Clear understanding of sustainable food systems and related topics
- Knowledge of Sustainability Impact Assessment and food sustainability indicators
- Experience of managing websites or similar digital platforms
- Experience of working or collaborating with small-scale food operators or community-based organisations
- Commitment to low/zero carbon dissemination events
- Knowledge and experience of conducting qualitative and quantitative data analysis.

#### **Desirable**

- Knowledge or experience of social enterprise business models
- Experience of managing work conducted by contractors such as web-developers or graphic designers
- Direct experience developing and maintaining websites or other online platforms
- Experience in a client facing sales or marketing role (experience of working with non-profit clients particularly desirable)
- Familiarity with at least one aspect of food sharing activities, e.g. shared food growing, cooking/eating or redistribution initiatives
- Knowledge and experience of low carbon or zero carbon dissemination events
- Experience of disseminating research beyond academic outlets.

## **GARDA CLEARANCE:**

Police vetting will be sought in respect of individuals who come under consideration for a post.

PLEASE NOTE: Applicants will be required to complete and return a Garda vetting form should they come under consideration for appointment. In some cases they may be requested to complete the form on the day of interview. This form will be forwarded to An Garda Síochána (Irish Police) for security checks on all Irish addresses at which they have resided. An Garda Síochána will make enquiries with the Police Service of Northern Ireland with respect to addresses in Northern Ireland. If an applicant is not successful in obtaining the post for whatever reason, this information will be destroyed. If an applicant, therefore, subsequently comes under consideration for another position, they will be required to supply this information again.

While applicants must complete information in relation to all addresses at which they have resided, the vetting is only done on addresses on the island of Ireland.

If an applicant has resided / studied in countries outside of Ireland for a period of 6 months or more, it is mandatory for them to furnish a Police Criminal Records Check/ Police Certificate from those countries stating that they have no convictions recorded against them while residing there. Applicants will need to provide a separate Police Criminal Records Check/ Police Certificate for each country in which they have resided. The Police Criminal Records Check/ Police Certificate must be dated after the date the applicant left the relevant country. Applicants should provide documentation in the English and/or Irish language. Translations must be provided by a registered translation company/institute in the Republic of Ireland; all costs will be borne by the applicant. Only original version documents will be accepted.

Applicants should be aware that any information obtained in the Garda Vetting process can be made available to the employing area.

It is the responsibility of the applicant to seek security clearances in a timely fashion as they can take some time. No applicant will be appointed without this information being provided and being in order.
