Applications are invited for the position of Research Fellow who will play a critical role in the delivery of EU research project CULTIVATE. The successful candidate will be committed to sustainability transitions and have experience of large European consortium projects and their management. This position has primary responsibility for providing a highly professional, proactive and comprehensive research management function. Candidates should have the ability to work on their own initiative and demonstrate their ability to work as part of a team. They should possess excellent verbal and written communication skills and be able to work to a very high level of accuracy and attention to detail with a range of stakeholders from across Europe and beyond. The role requires international travel for short durations for project meetings.

- *Candidates must have experience in project management* - Applicants should outline this experience and how it aligns with the expected duties and responsibilities of the post.
- *Relationship Management* - The applicant should demonstrate how their experience of managing and/or coordinating partner relationships or projects across academia, public, private and civil society actors.

Job Description

Standard Duties and Responsibilities of the Post

- Managing the day-to-day operational aspect of an EU project
- Having a clear picture of the project's deliverables and timelines, to ensure coordination among partners and timely delivery of milestones and deliverables.
- Ensuring completion of project documentation, keeping it updated and correctly organised.
- Keeping track of the project's budget / expenditure
- Ensuring compliance with the obligations of the Grant Agreement and the Consortium Agreement
- Liaise and reporting to the European Commission which includes preparation of periodic scientific and financial reports.
- Monitoring and reporting of project milestones and deliverables in accordance with EU deadlines
- Ensuring communication between all members of the consortium
- Organising project meetings, agenda, minutes, venues, etc.
- Reporting to the project leader, stakeholders and funder on the progress of the project and present recommendations and changes to the schedule if necessary
- Preparing (when necessary) amendments to the grant agreement
- Any other duties that arise from time to time as directed by the PI or nominee.

- We are seeking a dynamic person with a PhD (candidates with MSc may be considered) who is excited by managing a collaborative European consortium project.
- Excellent organizational and analytical skills and the ability to meet strict deadlines will be essential;
- Experience of PM Squared or other project management methodologies *and* a willingness to learn PM squared approach.
- The candidate will have excellent attention to detail, working with accuracy and rigor.
- The candidate will be able to demonstrate their ability to engage in team work and work on their own initiative.
- Excellent effective, diplomatic internal and external communication skills (written and oral) in English are essential; additional languages an advantage.
- Knowledge of the European funding environment is necessary and understanding of Horizon Europe an advantage.
- Good knowledge of research ethics, GDPR, data management and other institutional policies
- Enthusiasm for mentoring others and work collaboratively in teams.
- Proactive, flexible and problem-solving attitude
- Fast learner that requires minimal supervision
- Strong attention to process, detail and documentation
- Willingness and ability to travel within Europe is required.

- PhD/MSc in Geography, sustainability, food studies, agri-food area or related area
- Diploma or professional qualification in project management is desirable.

Project description

The EU-funded CULTIVATE project will support greater sustainability and resilience around food through a ground-breaking online social innovation platform – the Food Sharing Compass. Designed with and for food sharing initiatives (from seed sharing and social dining to surplus food redistribution and community composting), policymakers, food supply actors, researchers and citizens, the platform will make it possible to navigate sustainable food sharing landscapes. It comprises five tools: the SHARECITY200 Database (mapping, tracking and monitoring initiatives), the Food Sharing Calculator (assessing costs, benefits and impacts), the Menu of Good Governance

(options for policies to facilitate sustainable food sharing), the Library of Citizen Engagement (cataloguing tools for expanding food sharing activity) and the sustainable food sharing Community of Practice for food sharing initiatives.
